

NOTIFICATION

C-DIT has been offering Post Graduate Diploma in Computer Applications (PGDCA) course of one year duration on regular full time basis. It is now decided to offer the programme on part-time basis also commencing w.e.f 01.08.2023 under 2023 scheme for the benefit of the candidates who are employed. Approved CEP centres can register such candidates who will be allowed to undergo the programme as per the below given flexible time schedule, in such a way that they can to pursue the course along with their job.

Duration of the course - 1 year (2 semesters)

PGDCA Semester I: (Total training hours required is 500 hours) Schedule

Morning: 6:00 am to 8:00 am (2 hours)

Evening: 6:00 pm to 8:00 pm (2 hours)

Theory/ lab sessions will be arranged for a minimum total of three and half hours per day (morning and evening together) for 24 working days in each month in a period of 6 months, covering a total of 500 hours.

PGDCA Semester II: (Total training hours required is 750 hours) Schedule

Morning: 6:00 am to 8:00 am (2 hours)

Evening: 6:00 pm to 9:00 pm (3 hours)

Theory/ lab sessions will be arranged for a minimum total of five hours per day (morning and evening together) for **25 working days** in each month in a period of 6 months, covering a total of 750 hours.

Second Saturdays / local holidays can be included if extra timing needed.

All other terms and conditions regarding scheme and syllabus, eligibility criteria, course completion, assignments, lab, examinations and certification will be followed as per the approved full time scheme.

Interested candidates may approach any of the authorised C-DIT study centre, where such facility is available for pursuing their studies.
